How to become a Registered Electrician:

1. Complete this Application for Electrical Registration and return to the City Clerk's Office at 208 S. Rapp Ave., Columbia, IL 62236, or email to nancy@columbiaillinois.com or returned by fax at (618) 281-5477.
2. Minimum Requirements: Two years formal instruction or 4 years (8,000 hours) construction work experience.
3. The office of the Electrical Inspector will contact the applicant.

The current registration fee is \$25.00 to be paid at the City Clerk's Office by cash, by check (payable to the City of Columbia), or online by credit/debit at www.columbiaillinois.com. (The online option has an additional fee of \$1.50.) A registration certificate will be mailed to you 2-4 weeks after payment.

Annual registration fees due May 1 are required to maintain registration. If an electrical contractor fails to pay the registration fee for 2 or more consecutive years, the registration will be revoked and the contractor will have to complete the entire application process to regain registration.
