

AN ORDINANCE AMENDING CHAPTER 10.44.010 (PROHIBITED PARKING ON CERTAIN PUBLIC STREETS) OF TITLE 10 (VEHICLES AND TRAFFIC) OF THE MUNICIPAL CODE OF THE CITY TO PROHIBIT PARKING ALONG THE WEST SIDE OF COLUMBIA LAKES DRIVE FROM THE SOUTHERN MOST POINT OF BROOKFIELD COURT TO OLD STATE ROUTE 3 AND ALONG THE NORTH SIDE OF RAPP AVENUE EXTENDING SIXTY (60) FEET EASTERLY FROM THE EAST LINE OF PARKVIEW DRIVE IN THE CITY OF COLUMBIA, ILLINOIS

WHEREAS, the City Council of the City of Columbia, Illinois has determined it is necessary and appropriate and in the public interest to amend Chapter 10.44.010 (Prohibited Parking on Certain Public Streets) of Title 10 (Vehicles and Traffic) regarding prohibiting parking along the west side of Columbia Lakes Drive from the southern most point of Brookview Court to Old State Route 3 and along the north side of Rapp Avenue extending sixty (60) feet easterly from the east line of Parkview Drive.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

**Section 2.** Section 10.44.010 (Parking Prohibited on Certain Public Streets) of Title 10 (Vehicles and Traffic) of the City of Columbia, Illinois Municipal Code (the introductory paragraph of which states: "At any time it is unlawful to permit any vehicle to park in any of the following places, except when necessary to avoid conflict with other traffic or compliance with the directions of a policeman or traffic control device" is hereby amended by adding subparagraphs 75 and 76, to read as follows:

75. Along the West Side of Columbia Lakes Drive from the Southern most point of Brookview Court to Old State Route 3;

76. Along the North side of Rapp Avenue extending sixty (60) feet easterly from the east line of Parkview Court;

**Section 4.** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**Section 5.** This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Ebersohl moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Niemietz, and the roll call vote was as follows:






