ORDINANCE NO. 2840

AN ORDINANCE AMENDING TITLE 18 OF THE MUNICIPAL CODE OF THE CITY OF COLUMBIA, ILLINOIS TO ENACT THE FEES AND CHARGES TO BE ASSESSED FOR CITY SERVICES AND BUSINESS LICENSES IN THE CITY FOR THE CITY'S FISCAL YEAR COMMENCING MAY 1, 2010 AND UNTIL SAID TITLE 18 OF THE CITY'S MUNICIPAL CODE IS AGAIN AMENDED BY ORDINANCE OF THE CITY **ENACTED TO CHANGE SAID FEES AND CHARGES**

WHEREAS, the City Council of the City of Columbia, Illinois (the "City") has found and determined and does hereby declare that it is necessary and appropriate for the City Council to amend TITLE 18 of the City's Municipal Code, entitled:

"FEES AND CHARGES TO BE ASSESSED FOR CITY SERVICES AND BUSINESS LICENSE FEES TO BE ASSESSED FOR THE CONDUCT AND OPERATION OF BUSINESSES, OCCUPATIONS, AND PROFESSIONS IN THE CITY"

to change some of the fees and charges the City will collect for its ensuing fiscal year, which will commence May 1, 2010 and end April 30, 2011 and to continue in effect after the enactment of this ordinance until said TITLE 18 of the City's Municipal Code is again amended by enactment of a City Ordinance to change said City's fees and charges.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia. Illinois, as follows:

"TITLE 18" of the City of Columbia, Illinois Municipal Code, which is entitled: "FEES AND CHARGES TO BE ASSESSED FOR CITY SERVICES AND BUSINESS LICENSE FEES TO BE ASSESSED FOR THE CONDUCT AND OPERATION OF BUSINESSES, OCCUPATIONS, AND PROFESSIONS IN THE CITY" is hereby changed and amended as follows:

"TITLE 18"

FEES AND CHARGES TO BE ASSESSED FOR CITY SERVICES AND BUSINESS LICENSE FEES TO BE ASSESSED FOR THE CONDUCT AND OPERATION OF BUSINESSES, OCCUPATIONS AND PROFESSIONS IN THE CITY
