ORDINANCE NO. 2929

AN ORDINANCE TO AUTHORIZE THE PURCHASE OF MATERIAL FOR THE EVERGREEN LANE, LIBERTY STREET, WASHINGTON AVENUE AND HERMAN STREET WATER LINE REPLACEMENT PROJECT FROM HD SUPPLY WATERWORKS OF GRANITE CITY, ILLINOIS FOR THE CITY OF COLUMBIA, ILLINOIS.

WHEREAS, the City Council of the City of Columbia, Illinois (the "City") accepted the bid of HD Supply Waterworks of Granite City, Illinois (the "Supplier") at a regular meeting of the City Council held February 6th, 2012 to supply material for the Evergreen Lane, Liberty Street, Washington Avenue and Herman Street Water Line Replacement Project for a total price or sum of Thirty Seven Thousand Three Hundred Twenty Four Dollars and Eighty Five Cents (\$37,324.85);

WHEREAS, it is necessary and appropriate that the City should purchase the materials for the Evergreen Lane, Liberty Street, Washington Avenue and Herman Lane Water Line Replacement Project from the Supplier as the work maintains and upgrades the potable water system.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The City Council of the City of Columbia, Illinois does hereby authorize the purchase of the materials from the Supplier for the Evergreen Lane, Liberty Street, Washington Avenue and Herman Street Water Line Replacement Project per the material proposal received via sealed bid on February 1, 2012 attached hereto.

Section 3. The City Engineer, Ronald J. Williams, P.E., is directed to purchase the materials to be utilized for the Evergreen Lane, Liberty Street, Washington Avenue and Herman Street Water Line Replacement Project from the Supplier.

Section 4. This Ordinance shall be in full force and effect, from and after its passage, as provided by law.





SPECIAL PROVISIONS

The following Special Provisions supplement these specifications and in case of conflict the Special Provisions shall take precedence and govern:

PRODUCTS:

1. Water main pipe shall be PVE, AWWA C900, DR-18. Pipe shall comply with ASTM D-2241 and NSF 14, including markings. PVC Materials shall comply with ASTM D-1784 for cell classification 12454-B. Joints shall be compression type complying with ASTM D-3139, and gaskets shall conform with ASTM F-477 for elastomeric seals.
2. Water main pipe fittings shall be mechanical joint, ductile iron, 250 PSI pressure rating in accordance with AWWA standard C110 or C153
3. Gate valves shall be Mueller A-2380-20, AWWA C500 with 2" square nut or equivalent.
4. Fire hydrants shall be 3-way Mueller with Standard threads.
5. Valve boxes shall be cast iron, adjustable, Mueller H-10360 or equivalent.
6. All materials **must** be manufactured in the U.S.A.
7. All materials **must** be delivered to the jobsite or specified location within 2 weeks of placing the material order.

MATERIAL PROPOSAL

If this bid is accepted within 45 days from date of opening, the undersigned agrees to furnish any or all of the materials, at the quoted unit prices, subject to the following:

1. It is understood and agreed that the "Standard Specifications for Water and Sewer Main Construction" 6th Edition, shall govern insofar as they may be applied and insofar as they do not conflict with the special provisions and supplemental specifications attached hereto.
2. It is understood that quantities listed are approximate only and that they may be increased or decreased as may be needed to properly complete the improvement within its present limits or extensions thereto, at the unit price stated and that bids will be compared on the basis of the total price bid for each group.
3. Delivery in total or partial shipments as ordered shall be made within the time specified in the special provisions or by the acceptance at the point and in the manner specified in the "Schedule of Prices". If delivery on the jobsite is specified, it shall mean any place or places on the road designated by the awarding authority or its authorized representative.
4. Each pay item should have a unit price and a total price.
5. The unit price shall govern if no total price is shown, or if there is a discrepancy between the unit price and the total price.
6. If a unit price is omitted, the total price will be divided by the quantity in order to establish a unit price.
7. A bid will be declared unacceptable if neither a unit price nor a total price is shown.
