ORDINANCE NO. 2610

AN ORDINANCE TO AUTHORIZE AN AGREEMENT TO EMPLOY ALL TYPE TREE SERVICE, INC. OF WATERLOO, ILLINOIS TO PERFORM LIMB REMOVAL SERVICES IN THE CITY OF COLUMBIA, ILLINOIS.

WHEREAS, the City Council of the City of Columbia, Illinois (the "City") accepted the bid and awarded the contract to All Type Tree Service, Inc. of Waterloo, Illinois (the "Contractor") at a regular meeting of the City Council held December 3, 2007 to perform limb removal services throughout the City;

WHEREAS, the Contractor has executed and delivered to the City an Agreement to employ the Contractor to do and perform the work involved and the Contractor has provided the City with the required certificate of comprehensive liability insurance which names the City as an additional insured, which is in due and proper form; and,

WHEREAS, it is necessary and appropriate that the City make and enter into the Agreement to employ the Contractor to do and perform the work involved for the limb removal services aforesaid.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The Mayor is hereby authorized and directed to make and enter into the Agreement dated January 1, 2008 to employ the Contractor to perform the limb removal services described above (which is more particularly described in the employment Agreement), in the form attached, in at least two (2) counterparts.

Section 3. The City Engineer, Ronald J. Williams, P.E., is directed to deliver to the Contractor the Contractor's copy of the Agreement and to proceed with the preconstruction conference, if any, and the performance of the work involved.

Section 4. This Ordinance shall be in full force and effect, from and after its passage, as provided by law.


