AN ORDINANCE AMENDING CHAPTER 44 (PARKING PROHIBITED ON CERTAIN PUBLIC STREETS AND OTHER PUBLIC PLACES) OF TITLE 10 (VEHICLES AND TRAFFIC) OF THE MUNICIPAL CODE OF THE CITY BY ADDING SUB-SECTION 5 TO SECTION 10.44.020 (PROHIBITED PARKING AT OTHER PUBLIC PLACES) TO GOVERN PARKING IN STONE ARCH PARK IN THE CITY OF COLUMBIA, ILLINOIS

WHEREAS, the City of Columbia, Illinois ("City") and other partner jurisdictions are opening the Monroe County Welcome Center in Stone Arch Park in the City of Columbia; and

WHEREAS, it is anticipated that the welcome center, schoolhouse museum, and associated public plaza will draw as many as 1,450 vehicles per day; and

WHEREAS, the Mayor and City Council of Columbia, Illinois have determined that it is necessary, appropriate and beneficial to the citizens of Columbia to amend Section 10.44.020 (Prohibited Parking at Other Public Places) of Title 10 (Vehicles and Traffic) regarding parking at Stone Arch Park in the City of Columbia.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

<u>Section 1</u>. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

<u>Section 2</u>. Chapter 44 (Parking Prohibited on Certain Public Streets and Other Public Places) of Title 10 (Vehicles and Traffic) of the Municipal Code of the City is hereby amended to add Sub-Section 5 to Section 10.44.020 (Prohibited Parking at Other Public Places) as follows:

On the parking lot of Stone Arch Park (which park is adjacent to the intersection of Gall Rd. & Illinois Route 3 in the City), unless:

- a. One (1) or more of the occupants of the motor vehicle are visiting Stone Arch Park for the purpose of utilizing the park; or
- One (1) or more of the occupants of the motor vehicle are visiting or are staff members of the Monroe County Welcome Center or Shoemaker School Museum; or

c. One (1) or more of the occupants of the motor vehicle are City officials or employees.

Section 3. PENALTY. Any person, firm, or corporation violating this ordinance shall be fined not less than Seventy-Five (\$75.00) dollars nor more than Seven Hundred Fifty (\$750.00) dollars for each offense.

**Section 4**. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

<u>Section 5</u>. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.
