All vendors must have physical items for sale. No informational booths allowed. Only one of ea. type of item allowed. **Deadline for all applications is Friday, September 17, 2021.**
2. The non-refundable entry fee of \$35.00 should accompany your application.
3. Each vendor will be assigned an approx. 11'x11' area and each vendor is responsible for setting up/taking down their respective area, providing their own tent (no larger than 10'x10'), tables, chairs, equipment, change, etc.
4. Columbia FestiFall hours are 1–6 pm on Sunday, October 3 at Metter Park located at 206 E. Legion. Set up time begins at 10 am. Details regarding the event/booth locations will be emailed the week of 9/27/21.
5. No parking is permitted in the Metter Park playground parking lot – it is reserved for kids' activities and vendors.
6. All vendors are required to stay open until 6 p.m.
7. All vendor applications are subject to approval by the event committee. Limited space is available.
