**III. DELEGATIONS**

**A. City Administrator Candidate - Al Hudzik**

Mr. Hudzik informed the Council he initiated contact with Mayor Hutchinson and then addressed the Council regarding his qualifications and experience with the

City of Madison. Alderman Agne inquired about the size of Madison. Mr. Hudzik stated the population was approximately 7,000, had two full time positions in the administration department, a Chief of Police, a Supervisor of Public Works, and a volunteer fire department. Alderman Niemietz expressed concern about someone with strong human resource skills. Mr. Hudzik stated he has negotiated contracts for the public works and police departments, was actively involved in the bidding process for insurance, was administrator for the pension fund, and addressed personnel issues while an Executive Vice President in the banking industry. Mayor Hutchinson explained the need for a fulltime administrator. Alderman Oberkfell stated he would like to refer this issue to the Personnel Committee. Mayor Hutchinson stated a background check has already been performed and would like to appoint Mr. Hudzik as the city Administrator. Alderman Oberkfell and Unnerstall stated procedures need to be followed. Alderman Hejna stated the City does not need a City Administrator, especially since the department heads are managing the City well, and the lack of an administrator gives the employees a feeling of job security. Alderman Niemietz stated this is an appointed position, and in this case it would be on an interim basis. Alderman Niemietz then explained it took two years to finalize the hire the last time. Alderman Hejna stated the City does not need an administrator and the Mayor is only grandstanding for the position. Mayor Hutchinson stated he would wait to make the appointment until the Personnel Committee has a chance to discuss the issue.




