

ORDINANCE NO. 3356

**AN ORDINANCE LEVYING THE TAXES FOR THE
FISCAL YEAR ENDING APRIL 30, 2018**

An ordinance providing for and the making of the tax levy for the twelve months beginning May 1, 2017 and ending April 30, 2018 for the uses and purposes hereinafter set forth for the City of Columbia ("City") in the State of Illinois after adoption of Ordinance No. 3321 on April 17, 2017, which ordinance established the City's Budget for its fiscal year commencing May 1, 2017 and ending April 30, 2018 ("City's Budget Ordinance").

WHEREAS, the City Council of the City of Columbia, Illinois has determined that it is necessary to raise the sum of \$2,455,000.00 for the purposes set forth below:

Section 1. That there be and is hereby levied upon all the taxable property within the corporate limits of said City of Columbia, Illinois, as the same is assessed and equalized for State and County taxation for the City's fiscal year ending April 30, 2018 the sum of TWO MILLION FOUR HUNDRED FIFTY-FIVE THOUSAND DOLLARS AND NO CENTS (\$2,455,000.00) for the following specific purposes, as reflected in the City's Budget Ordinance, and in the respective sums as follows:

Section 4. This ordinance shall take effect and be in force from and after its legal passage and approval, and shall be numbered and known as Ordinance No. 3356 of the City of Columbia, Illinois.
